## **IFAWPCA-CHOI CONSTRUCTION FIELDMAN AWARD**

The award shall be for excellence in the field of construction and shall be reserved for construction fieldsmen of the position up to and including foremen, general foremen, and such other titles or designations with similar functions and responsibilities in the area of onsite working level supervision.

The award shall consist of a certification on form and cash prize in the amount as determined by the Board.

### Eligibility for Award

- To qualify for the award, a candidate shall be subject to the following eligibility requirements:
- He shall be a regular employee of a constituted construction firm of the Host Member;
- He shall have served in a field managerial or supervisory capacity in the construction of a project meeting the qualifications, and
- His service in the construction of the above said project shall have been on a fulltime basis and for the entire duration of the project construction operation, from mobilization to de-mobilization after completion of construction.

### Basis and Criteria for Rating Candidates

- A candidate for award shall be judged by the quality of his performance, in the capacity of a construction field managerial or supervisory position in connection with the construction of a project:
- Undertaken by a constituent construction firm of FCAN General Members or Associate Members
- With a final contract sum of not less than NRs 25 crore
- Employing a field force of not less than 100 people at peak; and
- Completed on a date falling within the Fiscal year 2079/80.

The performance of a candidate shall be rated by way of the following:

S.No	CRITERIA
1	General Field Management
2	Construction Operation
3	Leadership
4	Industry Responsibility
5	Operational Results

(The evidence must clearly be stated in the submitted CV)

(The recommendation letter should try to cover narratives to justify the nomination.)
