YEOH TIONG LAY- IFAWPCA AWARD FOR EXCELLENCE

The award seeks to honor the outstanding contributions made by an individual in the Construction industry. Such an individual must serve as a role model for present and future generations and by affording this recognition on the Award seeks to encourage members of the industry to strive for and attain greater heights by strengthening their excellence in leadership and enhancing their reputations.

The award shall consist of a certification and cash prize of USD 2000 or Equivalent.

Criteria:

A. Contribution to Regional Cooperation

- Details of the candidate's involvement in the field of contracting, building, engineering and construction
- Details of the candidate's involvement in the active promotion of regional cooperation among fellow contractors in the Asia and Western Pacific region
- Details of any recognition of eminent leadership and distinguished contributions accorded to the candidate in pursuit of the growth, progress and development of the construction industry in the Asia and Western Pacific region

B. Contribution to National Development

- Particulars of any recognition accorded to the candidate as a reference point or resource advocate by peers/colleagues in the industry. This includes details of the candidate's affiliation with various organizations, committees, advisory bodies, arbitration boards, etc.
- Particulars of the candidate's contributions in the promotion of the construction industry from the national to international levels.
- Specific examples where the candidate's exemplary leadership and meritorious contribution led to the development of a resilient, efficient and competitive construction industry.

C. Contribution to the Construction Industry

- Examples of candidate's collaborative activities with major industry players in the construction industry at international, national and local levels
- Particulars of the position/s the candidate has held in the local contractors' association that paved the way towards the development of an effective contractors' association.
- Details of active involvement in non-governmental organizations (NGOs) related to the construction industry
- Details of any appointments conferred on the candidate as Board Member or Committee Member at international, national and local levels

D. Role Model of the Youth

- Details of contribution made by the candidate to assist in the development of younger players in the industry and particulars of affiliation/involvement in the training, research and development etc. of these future members of the construction industry.

E. Any other exemplary professional and personal qualities and/or involvement in other socio-civic or charitable works.

(The evidence must clearly be stated in the submitted CV)

(The accompanying recommendation letter should try to cover narratives to justify the nomination.)
